

WARRANTY COVERAGE

Limited Lifetime Warranty

STEK Automotive Window Films Warranty applies to all STEK Automotive Window Films that have been professionally installed by an authorized installer. STEK Automotive and the Authorized Automotive Window Film Dealer (collectively referred to as "The Seller" herein) warrants that as long as you own your vehicle, STEK Automotive Window Films warranty applies.

WARRANTS AGAINST

1. Adhesion failure, peeling, bubbling, blistering and delamination from the glass, or other manufacturing defects.
2. Maintain film's color and never fade to other colors.
3. Maintain Solar Reflectivity properties without cracking or crazing.

In the event the product is found to be defective under this warranty,

The Seller will replace such quantity of the film that is proved to be defective.

The Seller will also provide re-application labor free of charge during the warranty period at The Seller's discretion. The manufacturer (STEK) DOES NOT cover the re-installation labor.

WARRANTY PERIOD

This warranty coverage begins on the date the STEK Window Film Product was installed and extends for the period of time the original registered owner of the automobile owns the automobile. This warranty terminates upon any sale of the automobile and is not transferrable.

NOT COVERED BY WARRANTY

The warranty is void if the product has been subjected to abuse or improper care. STEK Automotive is not liable for any loss, damage, expenses or cost, resulting from any one or more of the following:

1. Improper product care, maintenance or cleaning; or
2. Product abuse; or
3. Glass breakage; or
4. Non-automotive applications and/or non-complying film uses; or
5. Any other acts, occurrences, defects, faults or damages not caused by STEK Automotive.

This Product is to be used in compliance with all applicable local laws, statutes, rules, regulations and ordinances ("Laws") of the applicable country, state, province or local jurisdiction including, without limitation, tinted window laws.

FAILURE TO COMPLY WITH SUCH LAWS VOIDS THE WARRANTY. IT IS THE AUTOMOBILE'S OWNER'S RESPONSIBILITY TO COMPLY WITH ALL APPLICABLE LAWS.

PLEASE RETAIN THIS WARRANTY CARD AS IT MUST BE PRESENTED ALONG WITH YOUR ORIGINAL INVOICE TO A PARTICIPATING STEK AUTHORIZED AUTOMOTIVE WINDOW FILM DEALER TO RECEIVE WARRANTY SERVICE.

The availability or warranty service will vary for each country and from state to state or province to province depending on the law governing the legality of the automobile window tinting. This warranty covers the application of all STEK Automotive Window Film. The Seller reserves the right to test any films under warranty service.

THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY IN EACH COUNTRY OR STATE TO STATE OR PROVINCE TO PROVINCE.

This warranty card, customer's original invoice/receipt from installing dealer and the dealers invoice number (below) are required to process any and all warranty claims.

CLAIM

After installation, if any product failures are found under this warranty, contact the original authorized STEK Automotive installer who installed the film. If the original installing dealer is not available, you can submit a request for warranty service by sending email to STEK Automotive (info@stekautomotive.com). Do not forget to have your warranty card with original receipt as proof of purchase. If the specified documents are not submitted, the warranty service is void.

Care and Maintenance

Film Dry Time

The mounting solution used during the installation of your STEK Automotive window film may require a dry time. Cold or non-sunny weather conditions can lengthen the dry time, while warm weather and direct sun light exposure will shorten the dry time. Small water beads and a slightly cloudy look may appear during the dry time. If slow drying does occur, do not become alarmed. The film will eventually dry out.

DO NOT operate your windows until the film is dry.

Cleaning Instructions

To maximize the life of the window film, please follow these instructions for proper care and maintenance.

- Always use clean, soft materials to wash and dry your window film surfaces.
- Most common washing solutions can be used to clean the window film. Please avoid ammonia-based window cleaning products.
- A soft cloth (microfiber recommended) or a clean synthetic sponge is recommended for washing the window film, followed by another clean soft cloth or soft rubber squeegee for drying.

DO NOT CLEAN THE FILM FOR AT LEAST 30 DAYS AFTER INSTALLATION.
